- I. Call to Order: Meeting was called to order by John Peck at 1:32PM.
- II. Prior Meeting Minutes: The draft minutes from the last PC meeting were circulated. A motion was made by Eric Wagenaar to accept, the prior (05/30/24) meeting minutes. The motion was seconded by Ken Bibbins and passed unanimously.
- III. Resolution #8-2024 Transportation Improvement Program (TIP) Transit: A motion was made by Kristopher Reff to approve Resolution #8-2024, to make the following changes to the current TIP:
  - Add PIN 782099 for Citibus Facilities Enhancements and Maintenance.
  - Add PIN 782108 for the purchase of a Hybrid Fixed Route
  - Add PIN 782109 for Remote Streaming Security & Safety Equipment.

V. Local Stakeholder Group: Kristopher Reff mentioned that he attended the River Area Council of Governments (RACOG) Board Meeting in May to present on the WJCTC and the Local Stakeholder Group.

#### VI. Miscellaneous Items:

- New WJCTC Website Host: The HTC solicited vendors for a new host. The transition will happen this fall.
- PSA Study Updates: Keith Ewald gave a brief discussion/update on the three upcoming Task Assignments:
  - Safe Routes to School Study: The Consultant has been collecting data and narrowing down the priority areas. They are also grouping the areas of the highest need for bicycle and pedestrian accommodations. The next step is Stakeholder Outreach.
  - Resiliency Study: The Consultant has connected with the Jefferson County Hazard Mitigation Team to talk about the Multijurisdictional Hazard Mitigation Plan. They also gave a presentation on the Vulnerability aspect of the Study.
  - <u>Electric Vehicle Study:</u> The consultant stated that they are doing outreach and public engagement. Where it makes sense to spend the funding. There was some discussion of how municipalities will bear the cost of providing future EV infrastructure.

### VII. Old Business:

- Black River Trial Eastern Expansion: The Office of Parks Recreation and Historic Preservation (OPRHP) has had some preliminary discussions with National Grid regarding Right Of Way (ROW).
- With the Public Safety Building Access Study being completed it was recommended that the Highway Technical Committee go through the findings and narrow them down to the best options for a more in-depth study.

- Brownville Bridge: It was mentioned that the Brownville bridge is in construction currently with a fall timeframe for substantial completion. The existing bridge will be retrofitted to increase its capacity to carry utilities.
