# **Policy Committee (PC) Meeting Summary**

Wednesday, September 2, 2015, 2:00 PM
Dulls State Office Building
9<sup>th</sup> Floor Conference Room

- Call to Order & Acceptance of Previous Meeting Minutes: Chairman Jeffrey Graham called the meeting to order. A motion was made by Sharon Addison to accept the minutes from the March 2, 2015 Policy Committee meeting. John Peck seconded the motion and it passed unanimously.
- **II. Web Site Update:** Scott Docteur provided an update on the progress of the WJCTC website.
  - MPO staff has been in contact with Mark Holberg of WayNorth, LLC for creation of the website and for web hosting.
  - Recently MPO staff met with Mark Holberg to look at other MPO's websites and to develop a plan with regard to what WJCTC wants on their website.
  - A draft version of the website should be available for the October 2015 Technical Committee meetings with public rollout anticipated in the December 2015 timeframe.
  - o John Peck inquired with regard to the cost of maintenance of the website and the source of the funding for the website. The website will cost \$5000 +/- to establish. For simple maintenance items WJCTC staff (Alan Ricalton) can make the changes, for more complicated items WayNorth LLC will make the changes based on an hourly rate. Funding of the website will come out of the MPO's Planning funds.

- The target audience for the website will be the general public. It is envisioned that
  meeting minutes, documents for public review and comment, etc. will be posted on the
  website along with general information about the MPO.
- Gene Haynes mentioned that the presentation that Mark Holberg made to the Technical Committees was good and it appeared that he could do what the MPO requires. If for some reason things do not work out the website content is transferable.
- Sharon Addison indicated that consideration should be given to providing a connection from the MPO website to the Jefferson County Stormwater Coalition Website which is now up and running.

# III. Resolution 3-2015 Policy Committee Resolution Approving the WJCTC Public Participation Plan (PPP)

- A motion was made to accept Resolution 3-2015 by Scott Docteur and seconded by Sharon Addison.
- The following discussion ensued:
  - Scott Docteur explained that the Public Participation Plan is required by the Unified Planning Work program and that both technical committees have reviewed the document.
  - John Peck raised the question with regard to who would maintain the social media/Twitter account as discussed on Page #3 of the PPP. Alan Ricalton in conjunction with WayNorth LLC will be responsible for maintaining the account.
  - John Peck raised the question with regard to the language in the document that discusses Environmental Justice. It was explained that Environmental Justice a term that is tied to Federal nondiscrimination regulations contained in Title VI of the Civil Rights Act of 1964 and subsequent legislation. Environmental Justice could apply to the transit program as well as to alignment selection for highway and bridge projects.
  - Robert Hagemann questioned the length of document retention on the website mentioned in the PPP of 30 days. It was explained that the intent was for the documents to appear in draft form for 30 days during the comment period with the final version being posted indefinitely.
- Upon completion of the discussion the motion passed unanimously. A signed copy of this resolution may be found in Appendix A.

#### Resolution 4-2015 Policy Committee Resolution Approving an Amendment of the FFY IV. 2013/14 - 2017/18 Transportation Improvement Program to add FTA Section 5310 **Projects:**

- A motion was made to accept Resolution 4-2015 by Steven Kokkoris and seconded by Sharon Addison.
- The following discussion ensued:
  - John Peck raised the question with regard to whether private entities could apply for the 5310 funding. For an example he mentioned that he did not see Lundy Services from Carthage on the listing. Gene Hayes explained that funding from the program comes from the FTA and is administered by New York State. Private entities that provide public transportation are eligible for funding. If a particular entity does not appear on the listing it could be either that the entity did not apply or that they missed the deadline as four organizations applied for six grants in the most recent round. Gene Hayes also mentioned that the MPO may want to consider some form of outreach to potential 5310 recipients to make them aware of its availability.
- Upon completion of the discussion the motion passed unanimously. A signed copy of this resolution may be found in Appendix B.

#### ٧. Resolution 5-2015 Policy Committee Resolution Approving the Addendum to the 2008 **Jefferson County Coordinated Transit Plan:**

- A motion was made to accept Resolution 5-2015 by Sharon Addison and seconded by Donald Mattimore. It passed unanimously. A signed copy of this resolution may be found in Appendix C.
- VI. Local Stakeholder Group (LSG) Update: Donald Mattimore provided an update on the activities of the LSG. A meeting was held in April with seven municipalities attending and a second meeting was held in July with one municipality attending. Feedback from the LSG has been limited, however interest has been expressed for a Planning study with regard to the selection of a location for the Brownville bridge (welded truss over the Black River between CR 190 and NY 12F). Donald Mattimore has been forwarding the minutes from the various committees to the members of the LSG to keep them informed of MPO activities.

#### VII. **Miscellaneous Discussion Items:**

o Robert Hagemann questioned the population within the MPO. Owen Virkler indicated that it was in the 60,000 +/- range. The reason he was posing the question was that at the time of the 2010 census Fort Drum had a population of 19,000. Based on projections the value could drop to 15,000 by the time of the next census. He was questioning whether a drop in population in the magnitude of 4,000 persons would drop the population within the MPO below the 50,000 threshold at which the MPO is required.

- Jeffrey Graham posed the question with regard to what happens when someone requests work just outside the MPO boundary (e.g. bus service, water, fire protection, etc.) It was mentioned that work of the MPO is limited to within the MPO boundary.
- **VIII. Motion to Adjourn:** John Peck made a motion to adjourn, Sharon Addison seconded and the motion passed unanimously.
- **IX. Post Meeting Discussion:** A brief post meeting discussion was held with regard to the amount of lead time required between when a resolution is recommended by one of the Technical Committees and when the Policy Committee votes on it. The general consensus was that two weeks should be acceptable provided that the Policy Committee members have received a copy of the resolution to review.

It was also mentioned that future meeting dates for the PC are outlined in the Unified Operations Plan.
